

Washington Youth Tour— the experience of a lifetime

A big smile, a soft voice and a beautiful girl. This describes Shayla Walker as she begins to talk about her experience on Blue Grass Energy’s Washington Youth Tour (WYT) last summer.

Shayla, now a senior at Western Hills High School in Franklin County, was one of eight high school juniors selected to represent Blue Grass Energy on the WYT last June. The WYT takes place each summer when nearly 1,700 young cooperative members from across America visit the nation’s capital. It is an all-expenses-paid trip that sharpens leadership skills for future leaders.

She admits she had no idea what the WYT was until her mom came home one day with mail advertising the trip. She grins as she admits, “My mom made me apply. She told me, ‘You never know. Just give it a chance.’” And Shayla is certainly glad she did.


“I have several favorite memories. One was when we visited the Lincoln Memorial. The acoustics there are so cool. Another girl on the trip and I decided we were going to sing *Amazing Grace*. We started, and everyone began to join in. It was amazing.”

The National Rural Electric Cooperative Association initiated the

WYT in the late 1950s after then-Senator Lyndon Baines Johnson suggested to electric co-op leaders that they “send youngsters to the nation’s capital where they can see what the flag stands for and represents.”

When on the trip, participants learn about the cooperative business model and meet with elected officials with the opportunity to discuss issues that are important back home.

In addition to the Capital Hill visit, students sightsee, participate in group activities with students from other states and experience events like the Sunset Parade at the Marine Corps (Iwo Jima) War Memorial.
